#### **Compelling Evidence [1992]**


In Compelling Evidence, Paul Madriani, a brilliant criminal defense attorney, was once a promising associate on the rise with Potter, Skarpellos, a prestigious law firm specializing in the defense of "compromised" executives. One of its

cofounders is Ben Potter, Paul's mentor, whose faultless reputation has earned him a probable nomination to the U.S. Supreme Court.

In the aftermath of an affair with Ben Potter's wife, Paul left the firm and took up a self-imposed exile in a small solo practice. He must scramble for work amid the ghosts of his doomed affair while struggling to hold together the remains of a failing marriage.


#### Prime Witness [1993]

#### **Undue Influence [1994]**




#### The Judge [1995]

Steve Martini's explosive new thriller finds attorney Paul Madriani the unlikely defense lawyer for an old nemesis. Judge Armando "the Coconut" Acosta is arrested on charges of soliciting prostitution in a sting operation of

"johns," and few, including Paul Madriani, who has a long history of enmity with the judge, are sympathetic.

Abandoned by his friends on the Capital County bench, Acosta is forced, in an ironic twist, to ask Paul to save his career from impending doom. Paul initially rejects Acosta's pleas, but when Acosta's original defense lawyer is forced off the case by a zealous district attorney looking for revenge, Paul is required to step forward and defend the judge.

As the case proceeds, the young female deputy reserve officer who snared the judge is found brutally murdered, and Acosta is the prime suspect. The reason? The officer was the only person who could give evidence against the judge. With his client now charged with murder, Paul faces the most daunting, disturbing, and complex case of his career.



#### The Attorney [2000]


Paul Madriani is back in an absorbing new legal thriller by the New York Times bestselling author of The Judge and Undue Influence.

Lawyer Paul Madriani is called upon to defend a brilliant research physician – who just may be a killer – in this riveting new novel by the best-selling author of The Attorney....Madriani has ample

reason to suspect he's representing a guilty man. Dr. David Crone, a respected medical researcher and principal in mapping the human genome, is charged with the murder of a young colleague: twenty-six-year-old Kalista Jordan, an African-American research physician whose body washed up on a beach in San Diego Bay.

Forensic evidence links her murder with material in Crone's garage. 
damning loose end.

### The Arraignment [2003]

After a lawyer-friend is killed along with his client in a hail of gunfire outside the federal courthouse in San Diego, attorney Paul Madriani takes on another client who Paul believes is involved at the edges of the double murder. He takes the case not to defend the man, but to find out who killed his friend and why. Paul is tortured by questions of conflict, his duty to a client who may have killed his friend and the need to know the truth, wondering whether he himself had been marked for death only to have a friend die in his place. Paul finds himself with a window into places he never wanted to go, drawn into a vortex of crime that spans the Americas.

As he searches for the killer, Paul rides the crest of a dangerous wave involving international drug deals and the people who murder for money. Suddenly he realizes it is not heroin or cocaine that resulted in the murder of his friend, but a priceless piece of pre-Columbian art, something so dazzling in the information it holds as to be one of the treasures of the ages.

In a quest that takes Paul from California to Mexico and the Guatemalan border, he discovers that while the motive to kill may be driven by distant, exotic and ancient artifacts, the killer, like a serpent, lies much closer at hand.



#### Double Tap [2005]

Attorney Paul Madriani defends a highly decorated soldier on trial for murder and unwittingly steps into a maze of secrets and lies that the United States government – and possibly even his client – would rather leave hidden and

undisturbed.

In his new outing, Madriani is faced with daunting ballistics evidence, a so-called "double tap" – two bullet wounds tightly grouped to the victim's head, shots that could only have been made by a crack marksman. Madriani's client, Emiliano Ruiz, is an enigma, a career soldier who refuses to talk about his past though clearly he is a battle-tested pro. Ruiz is accused of killing a beautiful businesswoman and guru of a high tech software empire catering to the military.

One key to the case that's especially damning for Madriani's client: the murder weapon is one used only in special operations where the "double tap" has become the signature of the most skilled assassins.

Ruiz is sitting on a story he says he's not at liberty to tell – a seven-year-gap on his military resume for which Madriani can find no details. And more troubling, Madriani discovers that the victim and her company were

involved in a controversial government computer program designed to combat terrorists. Madriani finds himself in a deadly legal quagmire – with a client who refuses to help and prosecutors who stonewall every question about the victim's shadowy business and his client's past. Finding justice and the unvarnished truth has never been so elusive – or so dangerous.



#### Shadow of Power [2008]

The Supreme Court is one of our most sacred – and secretive – public institutions. But sometime secrets can lead to cover-ups with very deadly consequences.

Terry Scarborough is a firebrand. He's also a controversial law professor whose new book, Perpetual Slaves, presents evidence that the roots of slavery are still deeply imbedded in the U.S. Constitution. Scarborough has cunningly created a media-frenzy, and his book is rocketing up the bestseller lists, while fueling unrest nationwide. In the midst of his highly-charged book tour, Scarborough announces that he is about to unveil an even greater and more damaging controversy: a previously unpublished letter written by Thomas Jefferson (the "J Letter") that portends some deep secret about slavery at the nation's founding. But on the day he's to appear on national television to tell the world of this damning document, he is found beaten to death in a San Diego hotel room and a young man with unsavory connections is arrested for his murder.

As a favor to the young man's father, Paul Madriani takes the case—even though it looks like an open-and-shut conviction. Madriani, a brilliant defense lawyer, begins by pulling out all the stops to get the truth out of his young client—especially why, as an employee of the hotel and perhaps the last person to see Scarborough alive, he ran from the murder scene instead of reporting it to someone. Factoring in the man's admitted radical beliefs and an alleged plot to kidnap Scarborough, Madriani's faced with the near-impossible task of keeping the kid off of death row.

Traveling far and wide to talk to Scarborough's friends, Madriani thinks he's chasing blind leads — with no potential subpoenas in sight. But he doggedly pursues references to the J Letter, and uncovers a mysterious connection between this explosive historical document, Scarborough, and a sitting U.S. Supreme Court justice. Madriani suspects that the letter is at the heart of the murder and he won't let anyone stand in his way of

uncovering how one of the nation's top judges could be involved.

Madriani carefully treads a dangerous path through a complex legal minefield in one of the most politically and racially charged cases in U.S. history. Desperate to uncover the truth, he must hunt down the Jefferson document and risk exposing a high court justice without bringing more turmoil to an already uneasy public. But when Madriani discovers the astonishing facts behind the letter, the case breaks wide open and he must race against time to save his client's life.


entertaining novels yet in this New York Times bestselling series.


#### The Rule of Nine [2010]


